**Participation Requirements:**

- Have active membership status and be in good standing at time of registration and travel. New Agents must be beyond the trial period to participate.
- Register and make payments as required by the policies.
- GTI Agent and guest must attend all included scheduled seminars and events. Non-compliance may result in an add-on charge of up to \$1,000 per person.
- GTI Agent and guest must be an adult age 21 or older.
- Obtain and carry proper proof of citizenship as required for the ports we will visit.

**Cabin Share Policy:**

If you or your guest has any medical condition that we need to be aware of please let us know as soon as possible. Failure to notify us may result in losing your space on the Cruise FAM.

**Conduct:**

You are representing Global Travel International, Inc. on the Cruise FAM. Please conduct yourself in a professional manner.

**Payment and Cancellation Policies:**

GTI will only accept major credits cards (VISA, MasterCard, Discover Card, and American Express) as a form of payment.

**Trip Cancellation Insurance:**

Trip Cancellation and Interruption Insurance is recommended and available through your ResMax™ site with Travel Guard Insurance.

**Registration Confirmation:**

Confirmations will be emailed within 48 hours of your credit card being charged and payment confirmed. **PLEASE DO NOT MAKE NON-REFUNDABLE TRAVEL ARRANGEMENTS UNTIL YOU RECEIVE CONFIRMATION BY EMAIL, FAX OR PHONE.** GTI reserves the right to cancel the event for reasons including, but not limited to, insufficient participation.

**Air Transportation:**

Air transportation to the port city is the responsibility of the participant to obtain through their own ResMax™ site or other preferred method. **Please do not make non-refundable travel arrangements until you have received a confirmation.**

**Ground Transfers Between the Airport and Cruise Terminal**

Cruise line transfers between the airport and cruise terminal are the responsibility of the participant. Taxis are readily available at the airport.

**Travel Documentation Requirements:**

All passengers must provide **PROOF OF CITIZENSHIP and PROOF OF IDENTITY** for boarding the cruise.

- Government identification card including a photograph and physical description
